Avantages fiscaux

Individuals

You will benefit from a 66% reduction in tax due in respect of your donation up to a maximum of 20% of your taxable revenue. If any payments exceed this threshold, the surplus amounts may be carried forward over the next 5 years.

Example :

AMOUNT	DEDUCTION	ACTUAL COST
60€	39.60€	20.40€
150€	99€	51€
1000€	660€	340€

Businesses

As a sponsor, the sum of your donations will allow you to benefit from a reduction of 60% of the amount of your revenue or corporation tax up to a limit of 0.5% of your turnover. For donations which exceed this threshold, the surplus amounts may be carried forward over 5 tax periods under the same conditions and after annual tax deductions have been made (article 238 subsection1 of the general taxation code).
